With reference to the above cited subject, as per reference (1) the 'Fire Safety Compliance' was issued from Chief Fire Officer, Bangalore east Zone, Bangalore to the premises at **"M/s. Under the above circumstance the Karnataka Fire & Emergency Services Department is renewing the "Fire Safety Compliance Report" to **"M/s. Bharath Educational Trust (Vishwa Chethana Group of Institutions), No.52/1, Kurubarahatti, Muthagatti Road, Anekal Taluk, Bengaluru Rural 562 106"** subject to proper maintenance of fire fighting installations in the good working conditions and arrange for 40% of staffs/ employees training within 03 months from the date of issue of this report.





In case the fire prevention and fire fighting measures installed as per the recommendation of the department are not maintained in good working condition, if the evacuation measures are not properly followed and if any additional construction work is taken up in the building/premises, the Fire Safety Compliance Report deemed to be cancelled and necessary legal action will be initiated against the developer/management/tenant and also separate NOC has to be obtained from the department for the storage of chemicals, solvents, Petroleum products, LPG etc. in the premises/building.
